Biographical Sketch:

Noel George Harper was born on December 25, 1873 in Cheshunt, England, the son of Thomas Harper and his wife (nee Etheridge). Harper served in the Boer War in South Africa, and after the war ended he remained there until immigrating to Canada in 1907. He settled in near Kamloops, B.C. and purchased property in the area of Westsyde with the intention of starting a ranch and farm. Harper would continue working his property until his retirement shortly before his death. He also served during World War I, and was a member of the Kamloops Branch (No. 25) of the Canadian Legion. Harper was married to Nina Denniston Syme, with whom he had two daughters (Mollie and Nancy) and one son (John Phillip). Harper was also known in Kamloops for his love of sports, particularly polo and cricket. Noel George Harper died on December 28, 1954 in Kamloops, B.C. at the age of 84.

John Phillip Harper (also known as Jack) was the son of Noel George Harper and Nina Denniston Syme. Harper served during World War II and was a member of the Kamloops Branch (No. 25) of the Canadian Legion. He was also an active member of the Church of Cleopas. John Phillip Harper died on April 20, 1983 in Kamloops, B.C. at the age of 75.

Scope and Content:

Fonds consists of two agreements related to Noel George Harper's purchase of land and water rights for his farm and ranch in Westsyde, and a Subscriber Agreement for John Harper with the Royal Inland Hospital.
