Administrative History:

The Ministry of Agriculture (Province of British Columbia) is responsible for the production, marketing, processing and merchandising of agricultural products and food in British Columbia on behalf of the Provincial Government. The ministry was first established in 1894 as the Department of Agriculture, under the Department of Agriculture Act, and shared a Minister with the finance department. At this time the department was responsible for collecting and analyzing statistics relating to agriculture in the province for planning purposes and to encourage agricultural progress. In 1916 a separate minister was appointed to oversee agriculture, and a new Department of Agriculture Act was enacted to expand the scope of the department to oversee legislation relating to agriculture, horticulture, and pastoral industries. In 1947 the department was expanded further to oversee agricultural development and extension, field crops and seed improvement, horticulture, live stock, markets, plant pathology, entomology, apiary inspection, soil surveys, farmers' and women's institutes, agricultural associations, exhibitions, fall fairs, agricultural statistics, and publications. The department was renamed the Ministry of Agriculture in 1976, but went through further name changes to the Ministry of Agriculture and Food (1980) and the Ministry of Agriculture, Food, and Fisheries (2000) before returning to the Ministry of Agriculture.

Scope and Content:

Collection consists of publications by the British Columbia Ministry of Agriculture recording brands for cattle, horses, and bison in British Columbia. Publications are available for the following years: 1917 (Stock Brands); 1960-1962, 1964-1968, 1972-1974, 1977, 1978, 1984, 1987 (Horse and Cattle Brands); 1989, 1991, and 1992 (Horse, Cattle, and Bison Brands).
