Administrative History:

The Brocklehurst Community Hall Association was established circa 1950, for the purpose of building and maintaining a community centre for residents of Brocklehurst to promote social, cultural, and athletic activities and to raise funds for charitable purposes. The Brocklehurst Community Hall was built between 1950 and 1952 on land donated by John Desmond, with the first social event (a dance) occurring on May 16, 1952. The Association continued running the Community Hall until it was sold to the Fraternal Order of the Eagles in 1974.

Scope and Content:

Fonds consists of records relating to the operations of the Brocklehurst Community Hall Association. Records largely consist of Second Share Mortgage Certificates and receipt books which record original fund raising efforts of the Association, and a small amount of correspondence, financial records, reports, meeting minutes, and the constitution of the Association.

Custodial History:

Accession 1998.021 was donated to the Kamloops Museum and Archives on May 5, 1998 by Helen Saemerow, who acted as the treasurer of the Brocklehurst Community Hall Association.
