#### **Administrative History:**

The Inland Rod and Gun Club was formed in Kamloops, B.C. in 1903, but there is some evidence that the club operated informally prior to their first official meeting on August 7, 1903. The club's objectives included the protection and proposition of game, wild fowl, and fish, and the encouragement of planting of wild rice and other foodstuffs. The club hosted various challenge matches, tournaments, and trapmeets during their operation. In 1913 the club seems to have been renamed the Kamloops Gun Club, and was later amalgamated with various other gun clubs and militia organizations with similar interests in the Kamloops area. See also the administrative history of the Kamloops Target Sports Association.

#### **Scope and Content:**

Fonds consists of a minute book of the Inland Rod and Gun Club, membership lists, constitutions, information about firearms licences in various locales, correspondence, and a report from the Kamloops Game and Fish Protection Association. Fonds also contains a minute book for the Kamloops Gun Club.

#### **Custodial History:**

Fonds consists of accessions 0.2190 and 0.2568, which were donated to the Kamloops Musuem and Archives in 1952 by R.G. Pinchbeck and by an unknown donor, respectively. Materials were originally placed in the Vertical Files Collection, and were brought together during reprocessing in 2019. Materials from accession 0.2568 may have formerly belonged to Annie Bunyan (see Annie Bunyan fonds for more information), but were believed to be unconnected to her by former KMA staff.
