### Administrative History:

**The Kamloops Community Hotel Association** was formed in April 1927 with the purpose of building a community financed and owned hotel in downtown Kamloops to bolster the tourism and trade of the community. The group was led by president Archibald Galloway, a local druggist, and was comprised by local businessmen and investors. Stocks were sold locally to raise funds, and construction of a hotel (later named the Plaza) was completed on land located on the southeast corner of Victoria Street and 4<sup>th</sup> Avenue in 1928. After two years of operations, the Leland Hotel Company Limited (another locally owned hotel) offered to purchase the stocks of the Kamloops Community Hotel, an offer which was accepted in 1930 with stock transfer being completed in 1933.

**The Plaza Hotel**, located at 405 Victoria Street in downtown Kamloops, was constructed under the auspices of the Kamloops Community Hotel Association (led by Archibald Galloway) between 1927-1928. The hotel was designed in the Spanish American style by local architect E.T. Brown, with construction being carried out by local firm Johnston and Co. Alongside its hotel rooms, lobby space, and restaurant, the building also contained space for complementary businesses on the first floor. Early tenants included D.W. Rowlands (insurance), J.A. Dowding (real estate), Capital Cleaners, and a barbershop. The Plaza opened with a gala event on May 1, 1928 under the management of Charles Campbell, and soon became a destination for local travellers. Over the years the hotel continued to be popular with travellers, and was expanded in 1948 and 1959 to include additional rooms. In 2000 the Plaza Hotel was honoured with heritage building status by the Kamloops Heritage Society (later Kamloops Heritage Commission), and it continues to operate today as a hotel, restaurant, and entertainment venue.
