### Administrative History:

**The Order of Railway Telegraphers** was a union organization, which was first established on June 9, 1886 in Cedar Rapids, Iowa. The initial meeting was organized by Ambrose D. Thurston, and was meant to promote the interests of railway telegraphers (as distinct from commercial telegraphers). By the early 1890s the union began to take a more active role in negotiating wages and working conditions with the railroads of their membership, moving away from being a more fraternal organization and changing its name to the Order of Railroad Telegraphers. In 1898 the organization added a Mutual Benefit Department, which acted to provide benefits to ill or unemployed members, and was increasing its international membership into Canada and Mexico. By 1901 the organization had 30 system divisions with 10,000 members. During the early 1920s membership in the union was at a peak of 78,000 members across the USA, Canada, and Mexico, but the stock market crash of 1929 and the ensuing economic depression decreased membership. In 1965 the organization changed its name to the Transportation Communications Employees Union, and would merge with the Brotherhood of Railway and Airline Clerks, Freight Handlers, Express and Station Employees in 1969. By 2005 the organization was affiliated with the International Association of Machinists, and opted for a full merger of the unions in 2012.

### Scope and Content:

Fonds consists of documents associated with the Order of Railway Telegraphers and the organization's various successor unions and affiliate railroad unions, centred in Kamloops but including other communities throughout British Columbia. Materials include meeting minutes, seniority lists, constitutions, correspondence, and human resources documents such as schedule rulings, discipline and grievance correspondence, and job reevaluations.
