## **Administrative History:**

The Pringle Lumber Mill was a sawmill established in Westwold, B.C. by Andrew John Pringle in 1911. Pringle purchased a sawmill in Naramata with financial assistance from T.K. Smith, and transported the mill to his property on Douglas Lake Road in Westwold on sleighs. The operation was the first permanent milling operation in the area and operated until 1946 when Pringle sold the mill to Pat Kennedy and Ken Long. The mill was subsequently moved off Pringle's property.

# **Scope and Content:**

Fonds consists Canadian National Railway bills of lading, cheques, and income tax records of A.J. Pringle. Fonds also contains a psalm book and a car manual.

#### **Custodial History:**

Accession 1999.006 was donated to the Kamloops Museum and Archives on February 26, 1999 by John Thomas, after being found in a desk drawer.
