Biographical Sketch:

Dr. Andrew Yarmie is a retired history professor, formerly of Thompson Rivers University in Kamloops, B.C. Yarmie's community involvement includes acting as Chair of the City of Kamloops' Heritage Commission from 2011-2019 and as the director of the Kamloops Museum Association. He has worked on many heritage related projects in Kamloops, such as the heritage plaquing project and the development of walking tours, and he has published academically and popularly on the subject of local Kamloops and British Columbia history.

Scope and Content:

Fonds consists of oral histories and other materials gathered by Andrew Yarmie and associates Maribeth Plommer, Surya Naidu, and Susan Forseille on women's history, local history, and the depression era in Kamloops.

Custodial History:

Accession 1986.033 was donated to the Kamloops Museum and Archives in April 1986 by Maribeth Plommer and Andrew Yarmie. File 1986.033.001 Sources for Women's History in Kamloops (draft only) was initially placed in the Vertical Files by former Archives Staff. Accession 1991.012 was donated on April 2, 1991 by Andrew Yarmie for Surya Naidu, the creator of the records. Accession 1993.003 was donated on January 26, 1993 by Andrew Yarmie.
